### **Weddings**

#### **The Mr. Lincoln package (maximum 200 guests)**

\$4,500

- Private use of Vintage Rose Wedding Estate for rehearsals (up to 2 hours)
- Private use of Vintage Rose Wedding Estate on your wedding day 4 hours prior to ceremony for pre-ceremony preparations. If you need more time, please consult the owner; an additional charge may apply.
- Round tables for up to 200 reception guests
- Four rectangular serving tables
- White linen tablecloths and napkins
- Plates, stemware & flatware for 200
- Use of The Grand Parlour 4 hours prior to ceremony for dressing of bride, groom, bridal party, parents and grandparents only
- Vintage Rose Wedding Estate is available for bridal portrait photography sessions which must be scheduled in advance
- Private security during ceremony and reception

#### **The Queen Elizabeth package (maximum 100 guests)**

\$3,000

- Private use of Vintage Rose Wedding Estate for rehearsals (up to 2 hours)
- Private use of Vintage Rose Wedding Estate on your wedding day 4 hours prior to ceremony for pre-ceremony preparations. If you need more time, please consult the owner; an additional charge may apply.
- Mahogany Chiavari chairs for up to 100 wedding guests
- Round tables and Mahogany Chiavari chairs for up to 100 reception guests
- Four rectangular serving tables
- White linen tablecloths and napkins
- Plates, stemware & flatware for 200
- Use of The Grand Parlour 4 hours prior to ceremony for dressing of bride, groom, bridal party, parents and grandparents only

- Private security during ceremony and reception

**Damage Deposit:**

Refundable damage deposit required with either of the above packages \$250

**Beer/Wine Service:**

Additional fee if beer/wine is being served \$250

Please note, NO LIQUOR is permitted at weddings, receptions, rehearsals, etc. You will be required to obtain a Limited Special Occasion ABC permit and Host Liquor Liability Insurance naming Vintage Rose Wedding Estate as an additional insured. A copy of the ABC permit and Host Liquor Liability insurance coverage should be submitted to Vintage Rose Wedding Estate no later than fourteen (14) business days prior to the ceremony.

**Reservations do not include:**

- Catering and bartending services (ask about our preferred vendor list)
- Removal of decorations (unless optional feature is purchased)
- Rehearsal dinner (may be purchased separately)
- Bridal Shower, Groom’s Shower, Brunches or Luncheons (may be purchased separately)
- Overnight accommodations (may be purchased separately)
- Listed prices do not include applicable sales and/or occupancy taxes

**Deposit:**

The \$250 refundable damage deposit shall be payable at the time the reservation is made. One third of the total wedding fee shall also be required as a non-refundable down payment at the time the reservation is booked. The final payment and guest count is due 14 business days prior to your event.

**Insurance:**

Special Event Liability Insurance is required for all wedding packages and is due no later than fourteen (14) business days prior to your event. The insurance must, at the renter’s sole expense, provide and maintain public liability and personal property damage insurance, insuring Vintage Rose Wedding Estate, its owners, employees, and/or agents, against all bodily injury, property damage, personal injury and other loss arising out of renter’s use and occupancy of the premises, or any other occupant on the premises, including appurtenances to the premises and sidewalks. The insurance required hereunder shall have a single limit liability of not less than \$1 Million, and general aggregate liability of not less than \$2 Million. Vintage Rose Wedding Estate shall be named as an additional insured of said policy. If alcohol is to be served, please make sure the policy includes Host Liquor Liability coverage to protect you against alcohol-related accidents, as you are ultimately liable for the safety of your guests. Some catering services use their license and insurance to cover this – please check with your catering service.
